Medical Informatics 1999

*Application Deadline for Medical Informatics 1999: **March 15, 1999***

Sponsored by: The U.S. National Library of Medicine and the Marine Biological Laboratory (Woods Hole, MA)

Dates for the two offerings of the course: May 30 - June 4, 1999 and October 3 - 9, 1999

Medical Informatics 1999 is a week-long survey course designed to familiarize individuals with the application of computer technologies and information science in medicine. Through a combination of lectures and hands-on computer exercises, participants will be introduced to the conceptual and technical components of medical informatics.

Medical Informatics 99 is a National Library of Medicine fellowship program directed at medical educators, medical librarians, medical administrators, and young faculty who are not currently knowledgeable but can become agents of change in their institutions. Limited to 30 fellows for each one week session.

Admission to the courses is competitive; student selection is determined by review committees appointed for each individual course. Costs of attending this course, including travel, housing and meals at the MBL, are supported by the National Library of Medicine.

NLM has a web based browser of MeSH now available from the MeSH home page, www.nlm.nih.gov/mesh. It is designed to present, in hypertext, virtually all of the information contained in MeSH records. It should be of interest to indexers, catalogers, reference librarians, and others concerned with controlled terminology. It is not designed to link to a search engine, such as PubMed or Internet Grateful Med.

For those interested in providing a link to the browser, NIM suggests that it be opened as a separate browser window, as it does not provide navigation to other sites within NLM. Frequent users might choose to bookmark the browser directly.

The browser is a product of the Indexing Initiative. Credit for making it work goes to Florence Chang. Responsibility for the content rests with Stuart Nelson.

CHAPTER SHARING ROUNDTABLES---FOOD FOR THOUGHT: A TIME TO SHARE

The 1999 Chapter Sharing Roundtables at MLA's annual meeting will again be a luncheon event. This session will be held on Sunday, May 16 from 12:00 noon - 2:00 p.m. It provides an opportunity for chapter members to meet informally and share experiences on a variety of topics. All MLA members, especially chapter officers, committee chairs, and newsletter editors are encouraged to attend. Participants must register for the event and choose a table on the MLA *99 registration form; the \$15.00 lunch is required for attendance at the event this year. Additional information will be in the 1999 Preliminary Program; further information about the 1998 topics may be found at the Chapter Council Web page on MLANET (www.mlanet.org/cc/roundtables).

In response to feedback from 1998 attendees, several new topics have been added (Archives, Webmasters, Internet in Libraries, Internet and Security, and Intranets and Libraries); two have been deleted (Automation and Centennial); and several have broadened their focus (Communications/Newsletters, Finance and Chapter Treasurers, and Membership and Recruiting).

A brief description of the tables including some ideas discussed at the 1998 event follows:

Annual Meeting Planning

For anyone who is currently (or will be) involved in planning chapter meetings. Topics discussed in 1998 included factors influencing attendance; CE planning; and ideas for programs.

Archives

New topic for 1999. Topics may include ideas on how to set up and maintain your chapter archives and what to do with the information that is already there.

Bylaws

A valuable table for chapter Bylaws Committee members. Last year discussion included voting on amendments, as well as how much information about standing committees to include in the bylaws.

Chairs/Incoming Chairs

For current and incoming chapter chairs. This table provides the opportunity to network with peers from other chapters.

Communications/Newsletters

Chapter communications can cover different kinds of media. This roundtable will focus on newsletters - whether they be print or email. Other topics could include email discussion lists and ongoing public relations. 1998 topics included production of newsletters and the use of email and listservs to obtain and share information. Topics may focus on, but not necessarily be limited to, chapter-related issues.

Continuing Education

This table will focus on issues relating to chapter continuing education - how to decide what to offer; use of the CE survey developed by MLA's Continuing Education Committee; and communication with peers. Topics may focus on, but are not necessarily limited to, chapter-related issues.

Finance and Chapter Treasurers

Especially useful for incoming chapter treasurers. Current chapter treasurers provide input and experience. Chapter

Finance Committee members will also find it useful as Ray Naegele, MLA's Director of Financial and Administrative Services, is usually the resource person at this table. Topics discussed in 1998 included chapter incorporation, the MLA tax service, and use of excess chapter funds.

Governmental Relations

Participants at this table will discuss such topics as the activities of the MLA Governmental Relations Committee and the MLA/AAHSLD Legislative Task Force.

Internet in Libraries

New table for 1999. Participants may discuss such issues as Internet accessibility in health sciences libraries.

Internet and Security

Another new table for 1999. Discussion will likely address security issues that have been experienced by table participants and options for resolving these issues.

Intranets and Libraries

Yet another new topic for 1999. Discussion will revolve around Intranet issues as encountered in both the academic and hospital libraries.

Leadership Development

Participants will look at the issue of developing leaders within the chapter. They may explore such things as committee participation and mentoring.

Membership and Recruiting

Participants will look at such issues as recruiting new members, retaining older members, and ideas for chapter membership committees.

Networking and Collaboration

This table is primarily for networking among librarians - a place for participants to get ideas.

Professional Growth and Development

Participants may explore professional development as a tool to increase skills and advance services and as a way to encourage staff development.

Research

A topic of interest every year. Participants may look at recent research projects; how to stimulate research within the chapter; and statistical methodology.

Webmasters

A new topic for 1999. It was developed primarily for chapter webmasters to look at common issues and resolutions and provide a forum for exchanging ideas.

BYLAWS UPDATE

The new draft bylaws were mailed to the membership for approval in late October 1998. The membership approved the new bylaws and all four amendments which were added by interested members. The amended bylaws have been approved by the MLA Bylaws Committee.

However, bylaws are a living document. Two issues have been raised in the past few months which need to be addressed in the bylaws. After consulting with the members of the NCNMLG Bylaws Committee I proposed the following amendments at the Business Meeting on February 5, 1999.

1. Background: Some members have more than one NCNMLG membership, usually because they work at more than one institution. NCNMLG is an organization of individuals. Each individual should have one vote, regardless of how many memberships he or she pays for.

Proposal: Article III. Membership
Section 2. Rights and Privileges

ADD TO C. In any voting situation, each voting member shall have one vote only.

2. Background: Because two positions are at stake in the elections for MLA Chapter Council Representative/Alternative and for NCNMLG Nominating Committee Chair/Member there is a possibility of a tied outcome in both cases.

Proposal: Article IV. Officers
Section 3. Elections

ADD TO E: If a tie occurs, the Nominating/Election Committee shall make a selection by lot from among the tied candidates.

The language of this amendment is modeled closely on similar language in the MLA Bylaws.

These two amendments will be brought to a vote at the next Chapter Business Meeting on Friday, April 9. A two-thirds vote of the members present will determine the fate of these amendments.

We contacted NLM about this to make sure that their reports procedure had not changed;staff there verified that they WILL CONTINUE TO MAIL HARDCOPY REPORTS TO PARTICIPATING DOCLINE LIBRARIES as they have done in the past. NLM usually places a message on the DOCLINE banner screen when reports are available through ftp and also when reports have been mailed. NLM also encourages you to contact them directly by a specified date if you have not received your report.
