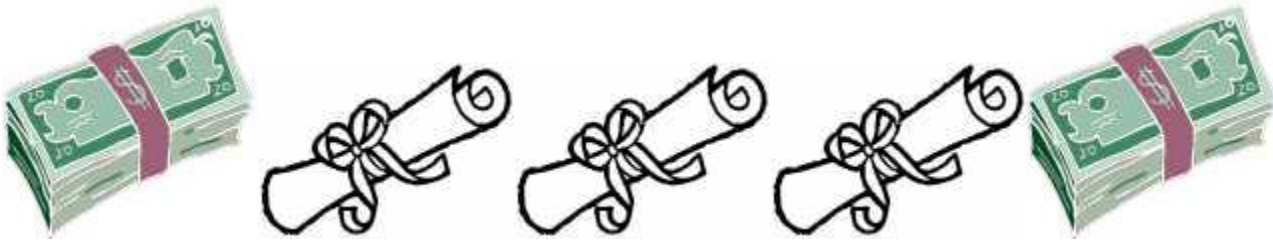

## STILL MORE GRANTS

### **Four EBSCO/MLA Annual Meeting Grants available**

The EBSCO/MLA Annual Meeting Grant was established by EBSCO Subscription Services to enable a medical librarian working in a health sciences library to attend the Medical Library Association (MLA) Annual Meeting. Four grants of up to \$1,000 each are available. The grants seek to encourage participation in MLA by providing an opportunity to attend an annual meeting (this year in Dallas, Texas on May 17-23, 2002 - <http://www.mlanet.org/am/>).

This is an excellent opportunity for librarians at any stage in their career who have not attended an MLA meeting to benefit from the outstanding programs and educational opportunities available at the Annual Conference. In order to qualify, applicants must be currently employed as a medical librarian and have at least two years experience as a librarian in a health sciences library at the time of the annual meeting.

The EBSCO/MLA Annual Meeting Grant Jury weighs other criteria in recommending an applicant to the Board, including the level of participation in the upcoming meeting, i.e.: presentations, committee memberships, and jury assignments.

Applying is easy! Fill out a simple form and write a 200-word statement answering the question, "What do you expect to gain professionally and/or personally by attending the MLA Annual Meeting?" ## FELLOWSHIPS

The Medical Library Association solicits candidates for the ISI/MLA Doctoral Fellowship to be awarded in 2002.

This award is sponsored by the Institute for Scientific Information to foster and encourage superior students to conduct doctoral work in an area of health sciences librarianship or information sciences. It is granted biannually. The \$2000 award supports research or travel applicable to the completion of a doctoral project or augments a larger, separately funded project relevant to health sciences librarianship which is part of the requirements of a doctoral degree. It may not be used for tuition.

The candidate must be a graduate of an ALA-accredited school of Library Science enrolled in a Ph.D. program with emphasis on biomedical and health-related information science. The candidate should have advanced to candidacy to assure acceptance of the project toward Ph.D requirements. Preference is given to applicants who have at least 80% of their course work completed and an approved dissertation prospectus.

The candidate must be a citizen of or have permanent residency in the United States or Canada. All applications must be received at MLA Headquarters by **December 1, 2001**. ### **Call to Order:**

Doug Varner called the meeting to order at 1:05 p.m.

### **Minutes:**

Approval of June 22, 2001 Executive Board Transition Meeting. Doug Varner accepted the June 22, 2001 minutes as written. Roger Brudno seconded the motion. Annette Osenga carried the motion. The minutes are approved as submitted by the secretary.

### **Treasurer's Report:**

Annette Osenga presented the "Balance Sheet Summary Report 6/1/01 through 8/31/01" as follows:

Doug accepted the "Balance Sheet Summary Report 6/1/01 through 8/31/01" as written. Rikke Greenwald second the motion. Barbara Ryken carried the motion. The treasurer's report was approved as submitted.

Annette will submit the "Balance Sheet Summary Report 6/1/01 through 8/31/01" to the newsletter. The next newsletter is due November 15, 2001.

### **Membership Checks**

Membership checks will be forward to Annette. Annette and Cynthia Seay to work out the logistics of who will photocopy the checks. Cynthia's membership process is to photocopy the check and keep a data entry list of the checks. Cynthia is presently on sick leave.

Before the next meeting, Annette will contact Mr. King, the auditor, to audit the books.

Annette asked if the following committees would be submitting budgets: Program, Nominating, AHIP and ILL. Program, Nominating and AHIP had no budget expenditures. David Brown will ask Ron Schultz to contact Annette in regards to ILL Budget.

Annette received a thank you note from Judith Levitt's family. The text of the card will be published in the next newsletter.

### **Bylaws Update**

Dorothy Schmidt discussed two proposed bylaw changes.

1. Under Article IV Officers, Section 1. Officers and Terms of Office Part A., the proposed change is to delete the past president as an elected voting officer for the third year. In recent years it has been difficult to find candidates to commit to the position of Vice-President/President Elect for three years. Two years would make the position more attractive. See page 5 of the *March/April NCNMLG Newsletter* for addition information.

Mary Beth Train stated the members have a copy of the proposed change. A print copy of the proposal must be brought before the members at the first general business meeting.

An electronic mailing and mail to those with no electronic address will be performed to notify members of the proposed change. To pass the proposed change, there must be 2/3 vote of those present at the Joint Meeting. This is a holdover for the first board meeting in mid November 2001.

2. The second issue is how much notice should be given on an upcoming meeting. The NCNMLG Bylaws state three weeks in advance. The MLA Bylaws state 30 days advance notice. The question is should there be a bylaws change. Annette checked the incorporation document which makes no mention of notice of a meeting. The original NCNMLG constitution states there should be three weeks meeting notice.

After discussion it was decided this is a minor point not worthy of discussion.

Rebecca Davis motioned to observe three week notification of meetings as reflected in the bylaws.

Mary Beth Train second the motion. Doug Varner carried the motion. The motion to observe the three week notification of meetings as proposed is approved by the board.

There are no stipulations in the bylaws which state the president can terminate an appointment at the president's discretion. The discussion will be tabled till the meeting in November. Dorothy will check the MLA Bylaws on this issue. Roger to gather sample clauses from other organizations. Doug will also gather information on how other organizations handle this issue.

### **ILL Coupon Report**

Doug Varner and David Brown went through the NCNMLG archives at UCSF to locate coupon records to figure out how many coupons are in circulation. Doug is attempting to locate invoices for cutting coupons.

David was asked why we don't charge sales tax. He replied we are not selling anything. It is not an object, but a symbol representing money.

Sara Pimental stated NCNMLG follows the Southern California chapter in setting up the coupon policy. David will contact the Southern California coupon manager in regards to this matter. Sara said we are not selling anything, but acting as a broker.

### **2004 Joint Meeting Update**

Rebecca contacted Kathy Murray, Chairman of the Pacific Northwest Medical Group, in regards to her interest in joining the 2004 Joint Meeting. The Pacific Northwest Group uses the joint meeting as a fundraiser. If acceptable to us they would budget accordingly for 2004, and come as our honored guest. This would include an additional 60-75 guest. However, two stipulations from the Pacific Northwest Group are CE classes to meet the needs of their group, and meeting space for an executive meeting. The CE committee would work with the Pacific Northwest to meet their needs. Additional meeting rooms would be set up for the Pacific Northwest Medical Groups business meeting.

Doug moved that NCNMLG collaborate with Pacific Northwest Medical Group in setting up and being our honored guest at the 2004 Joint Meeting in Sacramento CA. Mary Beth Train second the motion. Rebecca Davis carried the motion. The motion was approved. NCNMLG will collaborate with Pacific Northwest Medical Group for the 2004 Joint Meeting.

Roger Brudno reported 36% of the membership have renewed their membership. Three renewal notices (two specific and one general) are sent to members. Two new members have joined the group. Roger would like to work with public relations to drive up membership as members have been declining over the past three years. There are 223 current members.

Doug will have Cathleen Le Grand, Public Relations Chair, contact Roger in regards to recruitment and retention. Roger felt one way to publicize the organization would be to advertise in *Latitudes*.

### **MLA Benchmarking Initiative**

Doug Varner stated he plans to have Lynn Van Houten participate in meetings. She has benchmarking strategies in the works, and will be promoting the initiative.

Doug has scheduled the next board meeting for November 13, 2001. It will take place at an East Bay location either UC Berkeley, downtown Oakland Kaiser or Chiron. Sara and Doug are working on the meeting location. The plan is to have the board meeting as follows:

### **Web site redesign update**

Peggy Tahir will be working on the NCNMLG web redesign. Ed Bierman will continue to be involved in the redesign, but will be turning over the project to other individuals.

### **Other Items from Members**

Roger Bruno asked if the group has considered group buying power of full text references. Historically, NCNMLG has not structurally performed group purchase power. Rebecca Davis will contact MLA for models of collective buying power. Roger, Sara Pimental and Doug Varner will have an informal discussion on how to approach collective purchase power.

### **Adjournment**

Doug Varner called for a motion to adjourn the meeting. Mary Beth Train second the motion. Annette Osenga carried the motion. Meeting adjourned at 2:30p.m.

## PROPOSED BYLAWS ADDITION

I propose an addition to the bylaws to give the President the discretion to terminate committee appointments if needed. This addition is to become Part E, Section 1 under: Article VII.

The proposed addition is:

Article VII. Committees. Section 1. Standing Committees. Part E

***The President shall have the discretion to terminate appointments.***

### **Rationale:**

The chapter is proposing this addition to bring our bylaws into compliance with the MLA model bylaws revised 9/2000. The language in this revision follows exactly that of MLA's new bylaws. This provision in the bylaws will serve as a safeguard to the chapter and may protect it in case of legal action brought by a member.

### **Procedure:**

This announcement constitutes the initiation of the proposed amendment. Written notice shall be mailed to all NCNMLG members 30 days prior to the next business meeting, via the newsletter to be published November/December 2001. There will be a business meeting at the 2002 Joint Meeting in Scottsdale, Arizona. Providing there is a quorum of members present at that meeting, this amendment will be voted on. A two-thirds majority of the members present shall determine the disposition of the amendment.
